HURRICANE IAN DAMAGE UPDATE

September 28th was the one year anniversary of Hurricane Ian. Progress has been painfully slow in addressing the recovery needs at St. Edmund Church despite continuing efforts with the insurance company and the diocese that has included review by adjustors, engineers, and contractors. It has been determined that the 1897 original church building can be saved but the attached addition (kitchen, offices, bathrooms) will need to be replaced. Also, after further inspection, it was found that the 1930 church building has more damage than initially thought. A new roof, window leaks, and internal painting will need addressing. Paul Davis Restoration Company (Sarasota) is providing inspections and estimates.

Father Williamson and Senior Warden Pat Moore maintain contact with diocesan staff and the bishop regarding the status of recovery needs. Bishop Scharf expresses his interest and commitment to St. Edmund Church. He would like to see a new structure that will not only meet the current and future needs of the congregation but also can be used by the Arcadia community with possible revenue producing options. At the end of September FEMA approval was attained, although it is not known what that exactly means at this time. The current Hurricane Ian Designated Fund totals \$559,255.26 (insurance payment and contributions by diocese, parishes, and individuals). Insurance responsibility is not settled and further negotiation will be required with the additional damage identified in the church building and as plans for a church hall are determined.
